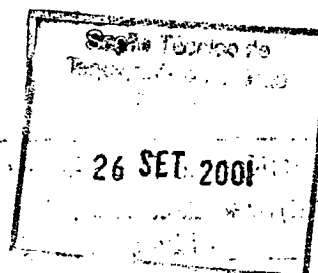

Evangelical Christianity and Political Democracy in Latin America

This project represents the first major effort to undertake a systematic, comparative study of the political impact of evangelical Christianity in Asia, Africa and Latin America. Evangelical Christianity is probably the second largest segment of world Christianity, after Roman Catholicism. However, its global political impact has been neglected by scholars, policy-makers and journalists. Our first study, *Evangelicals and Politics in Asia, Africa and Latin America*, which we commissioned at the start of our project, was just published in April 2001 by Cambridge University Press. The author, Brazil-based sociologist Paul Freston, Regional Director for the Latin American portion of our project, produced a broad survey of the material, covering more than 25 countries. As eminent British sociologist David Martin notes in the foreword to the book, "What [Paul Freston] offers is the guide to evangelical politics worldwide." Building on the foundations of this comprehensive survey, we will produce four additional volumes, all well underway. We will produce one edited volume on each of the three main regions, as well as a fourth edited volume of a systematically comparative nature. The three regional volumes will consist of six case studies. The Latin American volume will contain studies on Chile, Nicaragua, Guatemala, Brazil, Mexico and Peru. The conference in Lima will provide an opportunity for our research scholars to present their papers that will form the contents of the Latin American volume.

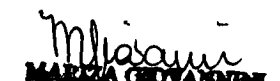

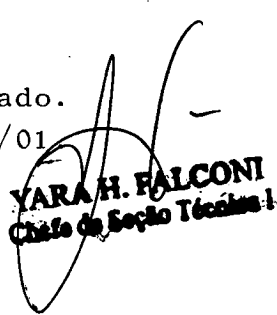

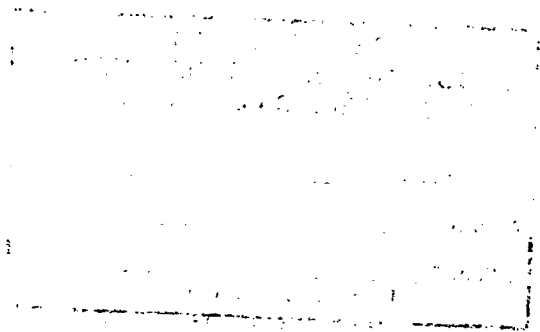
